- ☐ Sewer Authorization from Corix Utilities or Show Home Declaration (if applicable)
- ☐ ☐ Owner's Authorization of Agent
- ☐ Driveway Plan – separate one-page site plan (11" x 17") which indicates:
 - location and dimensions of driveway (as per Building Bylaw 1160)
 - suite parking if applicable (as per Bylaw 300)
 - retaining walls for driveway (no encroachments onto road right-of-way will be)
- ☐ Schedule B Structural - Professional Engineer retained for engineering component, seismic requirements, and sealed construction drawings
- ☐ ☐ Schedule B Geotech or sealed current Geotech Review
